### ANNUAL REPORT 2015-2016

#### I. Executive Summary

In 2015-2016, the IACUC reviewed and approved one new application for research on vertebrate animals at UNA. Dr. Glenn Marvin's proposal to study the effects of chronic low temperature on feeding and gut passage rate in salamanders was approved after review by committee members. The Chair and Vice Chair of the IACUC also inspected and approved the housing and condition of the animals currently kept in Dr. Marvin's facility.

No change in the charge of the committee is recommended at this time.

All business involving the full committee was conducted by email. The chair and vice chair met with Dr. Marvin on May 4, 2016 for an annual inspection of his research space in SET 388.

IV. What were the Committee's actions and accomplishments this year relative to each of the items of the charge?

The 2015-2016 IACUC committee was comprised of the following individuals: Dr. Jeffery Ray (Animal Research Experienced Faculty, Chair, 2016), Dr. Jean Ann Helm Allen (Non-scientific faculty, Vice Chair, 2017), Dr. Kyrel Buchanan (non-voting, by position), Ms. Janine Love (Staff, 2016), Dr. Randall Smith (DVM, non-voting), Mr. Jimmy Waddell (Staff, 2016), and Dr. Ryan Zayak (Faculty at large, 2016). The committee conducted business by email, including vice chair election, review of

proposal, and scheduling of inspection. Committee representatives met on May 4, 2016 to inspect the research lab of Dr. Marvin.

Dr. Ray and Dr. Helm Allen inspected Dr. Marvin's salamander holding facility in SET 388 to insure that vertebrate animals being used for research were being treated in accordance with approved protocols. Dr. Marvin's lab was found to be well-maintained and adhering to animal care and use standards. The committee also approved Dr. Marvin's proposal, "Effect of chronic low temperature on feeding and gut passage rate in a plethodontid salamander" to be conducted in his research lab.
