

CURRICULUM COMMITTEE
MINUTES OF THE MEETING OF SEPTEMBER 30, 2014
3:30 P.M., ROOM 207 OF THE GUILLOT UNIVERSITY CENTER

The UNA Curriculum Committee met at 3:30 p.m. on Tuesday, September 30, 2014, in Room 207 of the Guillot University Center. Approval of the minutes of the meeting of September 9, 2014

Dr. Rock moved approval and Dr. Lindley seconded the motion. The motion was approved unanimously.

Consideration of the request from the University Success Center for the required enrollment of FYE/LC (as approved by the Council of Academic Deans)

Dr. Rock moved approval and Dr. Kinney seconded the motion. The motion was approved unanimously. This item will be submitted to ACHE for approval.

Consideration of the request from the Honors Program for a Dual Degree Track (approved by Council of Academic Deans) – tabled at previous meeting

Dr. Raney made a motion and Dr. Beaver seconded the motion to approve a revised proposal that would remove references to “Engineering,” allowing for other dual degree programs that may be approved in the future. The motion was approved unanimously. During discussion, Dr. Brewton mentioned that there are other efforts underway by the Department of CSIS to create additional partnerships in the Dual Degree Engineering Program.

Consideration of the request from the Department of Mathematics for inactivation of courses, and title/course description revisions of other courses to reflect a reorganization of courses and laboratories

Consideration of the request from the Department of Human Environmental Sciences for editorial changes to correct inaccuracies to the concentration in interior design
