Approval of the agenda.

On motion by Dr. Gren and second by Dr. Winkles, the motion was approved, with one opposed.

Approval of the minutes of the meeting of October 11, 2017.

On motion by Dr. Winner and second by Dr. Raney, the motion was approved, with one opposed. One typo on the first page to be fixed.

Request from the Department of Human Sciences, Hospitality, and Design to revise course number: HES 362 and to add to the General Education component.
