- 1. Copyright Policy Senator Carrasco made a motion to accept the policy with a second by Senator Alvarado-Brizuela. Discussion led to withdrawal of the motion and a recommendation made by Senator L. Graham to table the discussion until next senate meeting. Senator Makowski seconded. It was recommended that a committee be formed to review the policy and include Senator Pate who has experience with copyright policies.
