The Faculty Senate of the University of North Alabama met May 7, 2015 in Commons 330 at 3:30 p.m.

that he will communicate by email as the process moves forward. He also stated that he feels the need to look at graduate programs and would like the university to continue to explore new ideas. He reported that as he spoke, Brenda Baker was working with the Board of Trustees to plan the investiture of the president in keeping with the rich history of the institution. The event could be early in the fall semester since Norton Auditorium will be off line in the fall for renovations. He stated that he wanted the event to be about the institution and not about him and that it was the hope to have the event funded from donors. He also thanked President Infanger for his friendship during his interview process.

Vice-President Thornell thanked the new senators for their willingness to serve. He stated that if enrollment numbers hold and the budget funding continues as indicated, we could be looking at one our best years.

Faculty Pool for University-Wide Promotion and Tenure Portfolio Review Committee

From Section 2.5.3 of the Faculty Handbook:

Annually, the Faculty Senate will identify a pool of at least 15 eligible members from all tenured professors at the Associate and Full Professor ranks for recommendation to the President to serve on this committee. From this pool of candidates, the President of the University will annually, in October, select members to serve for two (2) academic years. No faculty member from a faculty constituency will be appointed for additional terms until the entire pool from that constituency has been exhausted. Only then may professors be appointed to serve another term. Exemptions from service should only be granted in extreme circumstances and then only for one (1) term. Faculty may not serve on the committee while applying for promotion.
