Faculty affairs has drafted the following language for the faculty workload policy re: team teaching.

3.2.2 Faculty Workloads and Teaching Loads

6. Team-taught classes will be credited to only one faculty member and will rotate faculty members being given the credit each semester the course is offered.

Revision:

6. A team-taught course will be credited to each faculty member as one course toward each faculty member's regular teaching load. Faculty are expected to use a collaborative model and to attend all class sessions. Discretion may also be given to colleges based on individual circumstances. Applications for team-taught courses will be submitted to the Provost's office.

Dear Andrea, Yaschica, and George –

We have had a few questions about how we handle any team-teaching or co-teaching courses in the college. The Faculty Handbook stipulates that this should be credited to one faculty member one term and the other faculty member the next term. This presents the following problems:

1. Faculty workloads are not accurate and a potential concern with SACS
2. This assumes a course will be taught by the same faculty each time
3. This assumes that a course will be taught again in the future
4. This makes no provision for adjunct faculty

We would invite the Faculty Senate to consider reviewing this policy and allowing some provision for team teaching. This could fit into our CASE Faculty Workload Assignment Process that was submitted to the Faculty Senate three years ago.

Let us know what you think about this and the prospect of the Senate's action.

Re: Proposal for Faculty Handbook Policy Revision

Date: February 25, 2022

In preparation for the University's SACSCOC reaffirmation, the Section 6 (Faculty) subcommittee has compiled data and reviewed current University policies, procedures, and guidelines focused on faculty issues (e.g., faculty qualifications, academic freedom, faculty appointment and evaluation, sufficient number of full-time faculty). The committee identified a discrepancy between the University's 2019-2024 Strategic Plan and the Faculty Handbook that we believe requires remediation.

Theme Two: Academic Excellence and Innovation in the Strategic Plan includes an aspirational goal of full-time faculty members teaching 75% of all courses. The University is close to meeting this aspiration, with 72.8% of all courses taught in Fall 2021 by full-time faculty.

Appendix 2.A of the Faculty Handbook states that adjunct faculty will teach no more than 25% of the credit hours produced by a department. This policy was approved by the Faculty Senate in 1991-1992 when UNA enrolled approximately 5,500 students, offered 64 bachelor's degrees and concentrations, and 33 master's degrees. Over the last 30 years UNA has increased enrollment by over 60% ($\approx 9,000$) and now offers 219 bachelor's degrees and concentrations, 45 master's degrees, 3 education specialist degrees, and 2 doctoral programs – including a growing array of online programs. With this growth, many departments have strategically utilized adjunct faculty to teach larger sections of general education and lower-level courses to permit full-time faculty to teach smaller sections of upper-level and graduate courses – leading to many departments no longer meeting the criteria established in Appendix 2.A. A review of peer and aspirational institutions did not reveal similar policies regarding adjunct usage.

Therefore, our subcommittee is recommending that Appendix 2.A be modified to be more in alignment with the University's 2019-2024 *Roaring with Excellence* Strategic Plan aspirations. The subcommittee submits to COAD, the Shared Governance Executive Committee, and the Faculty Senate the proposed revision to the Faculty Handbook as outlined below.

Appendix 2.A – Policies Concerning Adjunct Faculty

The University recognizes the benefit both to the University and to students of instruction by adjunct faculty. The university also recognizes that it cannot develop or maintain quality programs by using only adjunct faculty. Therefore, the University will limit its employment of adjunct faculty to no more than 25% of the credit hours produced by a department except in compelling circumstances.

PROPOSED CHANGE

The University recognizes the benefit both to the University and to students of instruction by adjunct faculty. The ~~u~~University also recognizes that it cannot develop or maintain quality programs by using only adjunct faculty. Therefore, the University **seeks to** limit employment of adjunct faculty to no more than 25% of the **total number of courses taught by each department, with exceptions in compelling circumstances.**

The university will fully adopt Simple Syllabus as the university's syllabus repository this Summer. Currently, syllabi are only available to faculty and enrolled students via Canvas. One of the capabilities of Simple Syllabus that we plan to implement is a public-facing searchable website. Such a page would allow current and prospective students to view syllabi. This feature would enable students to determine course appropriateness, textbook needs, schedule information, planning, and sharing with employers. Faculty can control which components of their syllabi are publicly visible. The Faculty Senate's endorsement of this feature is requested, as it would encourage faculty adoption of this feature across campus.

To that end, I have drafted a resolution to present to Faculty Senate.

Resolution In Support Of Simple Syllabus Public-Facing Syllabus Repository

WHEREAS, the University of North Alabama has adopted Simple Syllabus as its syllabus repository; and

WHEREAS, syllabi housed in Simple Syllabus are currently available to faculty and enrolled students only via the university's learning management system; and

WHEREAS, Simple Syllabus can make Syllabi available via a searchable, public syllabus repository website; and

WHEREAS, prospective and current students could use syllabi to determine course appropriateness, textbook needs, schedule information, planning, and sharing with employers; and

WHEREAS, individual faculty can control the public visibility of components of their syllabi within Simple Syllabus; now, therefore, be it

RESOLVED: That the Faculty Senate of the University of North Alabama endorses making syllabi publicly available via the Simple Syllabus Syllabus Repository website.

SUBJECT: Duo authentication app on personal devices

We support the ITS initiative to improve the security of UNA's digital networks and do not oppose the use of two-factor authentication to access UNA systems. That said, various faculty and staff members of Collier Library are concerned with the University's implementation of the Duo app and the decision-making process that was behind this mandate. As it stands, it seems that one department unilaterally decided that every employee would be required to download an app to their personal device in order to perform basic aspects of their job, such as accessing email.

We have strong reservations about requiring every employee to download and use an app on a personal device in order to perform certain aspects of their job. Several library employees asked Ethan Humphres, Executive Director of Information Technology Services, questions via email related to the Duo app. A specific question asked was if there was a way to receive a passcode via text notification without downloading the app. In his response email, Mr. Humphres indicated that texts were a Duo option, but the University had chosen not to pay for this feature.*

Some of our specific questions/concerns are:

- Mr. Humphres attended the Staff Senate in September 2021 to explain the Duo app and allow for questions. He never attended the Faculty Senate or submitted the information to that body. Why was the Faculty Senate not given an opportunity to address the issue, raise concerns, or ask questions? The Technology Advisory Committee was also not consulted, further circumventing the shared governance process.
- What if an employee refuses to download the app on their smartphone or another personal device? Will ITS provide them with another way to authenticate and access UNA systems? Will the University punish or fire the employee for refusing to download the app?
- Two library employees have phones too old to download the app. The employees were told they would be given a hardware token device to use instead. They were told there would be a \$50 fine if the device was lost. This would effectively mean the employees would be charged \$50 to access the UNA system to perform their jobs.

In conclusion, we feel the handling of this situation sets a bad precedent, in that it did not follow the appropriate shared governance process. We propose that ITS provide alternative authentication processes that do not require downloading an app to a personal device, such as texting a passcode to users.

* Mr. Humphres' reply to the question of whether employees could receive a text message in lieu of downloading the Duo app.

"Once enabled for applications (such as e-mail), the app is the only method for confirming your second factor of identification to our protected applications. This is for two reasons. The first reason is cost. It costs the University extra each time a text or phone call is placed because a service is required to facilitate the communication."

Subject: RE: Reminder: Action Required - Securing your UNA e-mail with multi-factor authentication (MFA)

Currently, the only phone/text application that is available is through the registration portal itself. The ability in the registration portal is through necessity to allow options to register your device.

Once enabled for applications (such as e-mail), the app is the only method for confirming your second factor of identification to our protected applications. This is for two reasons. The first reason is cost. It costs the University extra each time a text or phone call is placed because a service is required to facilitate the communication. However, utilizing the app (or using a

code from within the app) is part of the built-in functionality. The second reason is security. The app registration and connection is more secure than a simple text/call. For example, how many of us have received unwanted text messages or calls? Scammers can use the same communication method to compromise your account. For that reason, the security best practice recommendation is to use the app.

With that said, the app provides codes as well. After downloading and installing the app, it produces a code each time it is opened and that code can be used for authentication. Utilization of that code does not use data (and can even be used in airplane mode). Utilization of the app does use a small amount of data.

I hope that provides some clarification and insight into the process. Let us know if you have any more questions or need more information.

What are my authentication options?

- **Duo Push**– if you have the Duo Mobile App installed on your smartphone or tablet, you can receive a push notification. From the app, you can approve or deny the login attempt.
- **Passcodes**– You can receive a passcode by the UNA logo in the Duo Mobile App, this does not require any wireless connectivity.
- **Phone Call** – you can receive a phone call on your mobile phone or landline phone. The call will give instructions on approving or denying the login attempt. This option is not available for all applications.

Subject: Action Required - Securing your UNA e-mail with multi-factor authentication (MFA)

Part of our efforts to secure and protect our technological assets revolve around our UNA credentials. To protect those assets, we are implementing multi-factor authentication (MFA) for e-mail. Our initial groups have been successfully utilizing MFA to protect their e-mail for some time and we are now rolling it out to all campus users.

Since MFA utilizes a second device for verification, your device needs to be registered. To reduce complications that will delay access to your e-mail, you should register your device before we enable MFA. On our website, www.una.edu/its under the "Duo" link (<https://una.edu/its/duo1/duo.html>), there are tutorials and step-by-step instructions regarding how to register your device (or search "Duo" on the UNA website). If you utilize another UNA service with MFA, your device is already registered. If not, the instructions on our site can walk you through that process (it is easiest to use a computer to access/follow the instructions, while having your device ready to acknowledge any prompts).

Beginning **Tuesday, March 22, 2022 at 9AM**, we will enable your personal UNA e-mail accounts to utilize MFA. If you register your device early with the Duo application, it will be a smoother transition. Once we enable MFA for your account, you will notice a few changes. If you have any issues or are unable to progress past a certain point, please contact us via e-mail at helpdesk@una.edu or via phone at 256.765.4865.

Once enabled on your account, you will likely see the following (although some of these results may be a little delayed):

- When you attempt to access Office365 on the web, you will be prompted to authenticate a second time with MFA.
- The Outlook client on your computer will prompt you to log in again and request MFA authorization.
- OneDrive on your computer and mobile device (if configured) will request you log in again and request MFA authorization.
- The mail app on your mobile device will request you log in again. For some users, it may be necessary to drop and recreate the account on your mobile device. This will not cause any loss of data and we have instructions regarding how to properly reset your account on your mobile device.

Anytime you see the MFA prompt, you can note in the system (with a check box) that your device should remember you for 30 days. If you do not mark to remember for 30 days, you will be prompted each time you log in.
