The Computing and Mathematic Building should be ready to occupy by semester's end. Demolition of LaGrange Hall is nearing completion. Leo is doing well and continues to be well taken care of by his team of volunteers. A team from USDA gave another score on Leo's habitat and their inspection.

Provost Kinney provided updates on issues relating to the Bookstore and encouraged faculty members and departments to reach out to Follett and Cindy Conlon with any concerns. Regarding the walkways on campus from the snow event in January 2024, two contractors were hired to clear at least one path to each building. The Dean of the Library search is ongoing and chaired by John McGee. Changes in COBT due to Dean Carnes returning to teaching will allow
