## III. Approval of minutes from the Athletics Committee meeting on September 29, 2021

### IV. Minority Opportunity Workgroup Report

Ms. Janae Lyde, chair of the Minority Opportunity Workgroup, stated that the Minority Opportunity Workgroup (MOW) met on October 6, 2021. At the meeting, the workgroup discussed the following:

- Tutor Track is a useful tool that UNA Faculty and Staff use to submit grades and feedback. Coaches are able to use the information from the faculty and staff are able to engage quickly with their student-athletes.

## VII. Athletic Directors Report

Dr. Josh Looney updated the committee on the following:

- The NCAA Special Convention was held on Monday, November 15, 2021. No votes were taken at the convention. The NCAA Convention will be held January 19-21, 2022. One of the topics of discussion for the convention in January is the NCAA Constitution. The most important topics discussed on Monday, November 15, 2021 were:
  - o Revenue Distribution
  - Access to Championships
  - Voting Rights
- The bid for Football Locker Room Project is due November 30, 2021. The construction for the project should begin in January of 2022.
- The bidding process for the indoor softball hitting facility will begin in March of 2022. The action items from the NCAA for UNA is to enhance the experience for female student-athletes. Also, personnel for coaches for women's sports.
- The search has begun for the Head Volleyball Coach.
- There are no updates for the football stadium but continues to be a priority.
