ANNUAL REPORT 2024-2025

I. Executive Summary

During the 2024–2025 academic year, the Readmissions Committee convened once to review student requests for reinstatement. The Fall 2024 meeting was held via Zoom on August 20, 2024, during which the committee evaluated three student applications for readmission. Committee members engaged applicants in dialogue to expand upon the information provided in their written submissions, ensuring a thorough review of each case.

The scheduled Spring 2025 meeting on January 7, 2025, was cancelled, as no applications for readmission were received.

Overall, the committee effectively fulfilled its responsibilities by providing a fair, consistent, and student-centered process for evaluating readmission requests during the academic year. Committee members asked the students questions that encouraged them to elaborate on the responses given on the readmission application.

- 6. To submit a final written report electronically by the first day of fall semester to the Provost and Executive Vice President for Academic Affairs with a copy sent to the Chair of the SGEC

The meeting for January 6, 2025 was cancelled.

IV. What were the Committee's actions and accomplishments this year relative to each of the items of the charge?

The Readmissions Committee served as a board of appeal for undergraduate readmissions as outlined in the committee charge. In keeping with items 1–3, the committee acted in an advisory capacity to students, offering guidance on matters such as credit hour enrollments, participation in counseling, and the use of other University resources.

During the Fall 2024 meeting, held on August 20, 2024, three students submitted appeals for readmission. Two students attended the meeting, and both were readmitted to the university. Each candidate was invited to meet with the committee to provide additional context and respond to questions regarding their applications. Following a thorough review and discussion, decisions were rendered on each case. Consistent with practice from prior years, the committee continued to conduct short interviews with candidates, a process that provides students an opportunity to expand on their written applications. The committee intends to continue this approach going forward.

No appeals were submitted for the Spring 2025 semester, and the scheduled January 6, 2025, meeting was cancelled. The committee did not make proposals that would affect items 4 and 5 of the charge during this academic year. Submission of this report fulfills item 6 of the committee charge.
