A BILL TO BE ENTITLED AN ACT

- I. This Act shall be known and cited as the Scholarship Clarification Act.
- II. The purpose of this bill is to amend Code of Laws section 404 to select one choice of verbiage regarding the scholarships and salaries of SGA officers for consistency and ease of understanding for any reader.
- III. 404 currently reads:

Chapter 404 Salaries for the SGA Executive Officers and Chairs

- 404.3 Salaries for said officers shall be:
  - 404.3.1 The President of SGA shall receive a \$2,500 scholarship for each semester.
  - 404.3.2 The Vice President of SGA shall receive a \$1,500 scholarship for each semester.
  - 404.3.3 The Secretary of the SGA shall receive a \$1,000 scholarship for each semester.
  - 404.3.4 The Treasurer of the SGA shall receive a \$1,000 scholarship for each semester.
  - 404.3.5 The Freshman Forum advisors shall each receive \$700.00 per semester.
  - 404.3.6 The Diversity and Inclusion Advocate of SGA shall receive \$225.00 per semester.
  - 404.3.7 The SGA Communications Director shall receive a \$225.00 payment once in the Fall semester and once in the Spring Semester, provided by the SGA Senate Budget
  - 404.3.8 The SGA Historian shall be paid \$225.00 annually, paid at the end of each semester provided by the SGA Senate budget.

404.3.9 The SGA Chairs, Pro Tempore, and Chief of Staff shall receive a \$225.00 payment once in the Fall semester and once in the Spring semester, starting the semester after they are installed.

IV. 404 now shall read:

#### Chapter 404 Scholarships for the SGA Executive Officers and Chairs

404.3 Scholarships for the following officers shall be paid at the beginning of each fall and spring semester that they are in office. Said officers shall receive:

404.3.1 The SGA President shall receive a \$2,500 scholarship.

404.3.2 The SGA Vice President shall receive a \$1,500 scholarship.

404.3.3 The SGA Secretary shall receive a \$1,000 scholarship.

404.3.4 The SGA Treasurer shall receive a \$1,000 scholarship.

404.3.5 The SGA Freshman Forum Advisors shall each receive a \$700 scholarship.

404.4 Scholarships for the following positions shall be paid each fall and spring semester that they are in office. Said positions shall receive:


404.4.1 The SGA Diversity and Inclusion Advocate shall receive a \$225 scholarship.

404.4.2 The SGA Communications Director shall receive a \$225 scholarship.


404.4.3 The SGA Historian shall receive a \$225 scholarship.

404.4.4 The SGA Chairs, Pro Tempore, and Chief of Staff shall each receive a \$225 scholarship.

V. This bill will become law upon ratification by two-thirds (2/3) vote of the University of North Alabama Student Government Association Senate and the subsequent approval of the Student Government Association President and Vice President.


