Student Organizations have received funding from the Student Activity Fund since the beginning of the fiscal year, October 2023. These allocations are managed by the Budget Oversight Committee of SGA.

## SGA ENDOWED SCHOLARSHIP

Scholarships were awarded to 4 students, totaling \$2,630.

Since the scholarship's creation, \$21,920 has been awarded to 32 students.

Raised \$2,000 by hosting 5 spirit events, 1 candy-gram sale, and a t-shirt, sweatshirt, and tote bag fundraiser to support the SGA Endowed Scholarship. It had a market value of \$66,753.72 as of April 2024.

The journey to establish the scholarship began in 2010, and it took five years to raise \$25,000 to endow it. The first scholarships were awarded in 2016. The SGA Endowed Scholarship is managed by the Treasurer who creates a committee to select the recipients.

Pro-Tempore Olivia Britton was awarded the Outsanding delegate award at CLEG

CLEG is the Alabama Collegiate Legislature
Conference that is hosted annually in
Montgomery, Alabama at the state capitol
building. At CLEG students have the
opportunity to participate in mock
government in all branches of state
government. This year was UNA's first year
back to CLEG since 2019. SGA had the
honor of winning the Speaker's Cup award
which is voted on by peer institutions on
overall character, professionalism, and
knowledge of parliamentary procedure. Our
delegation also had a mock bill pass
through both houses and was signed into
law by the YMCA Collegiate Governor.





### LEGISLATION PASSED

## **CONSTITUTIONAL AMENDMENTS**

## Bill 23-01 The Senate Re-Apportionment Amendment

Changed the number of senators based on college population to a set amount of 30 senators: 25 elected and 5 appointed. The seats shall be distributed to each academic college based on the percentage each college has out of the total student population.

## Bill 23-02 The Freshman, International, and Transfer Seats Amendment

Amended the Constitution with regard to the five (5) appointed seats.

One (1) is reserved for freshmen, two (2) each are reserved for international and transfer students.

# Bill 23-03 The Freshman and Transfer Senator Constitutional Changes Amendment

Set up a temporary committee to re-evaluate the number of senators each year prior to an election.

#### Bill 23-04 The Constitutional Amendment Effective Date Change Amendment

Changed effective date of an amendment from the next academic year to the next semester.

#### Bill 24-01 The Freshman Forum Advisors Amendment

Added an additional SGA Advisor for Freshman Forum.

### CODE OF LAWS

#### Bill 23-11 The Copies of Resolutions and Bills Act

Provided the Secretary with paperless options to present legislation to senators.

#### Bill 23-12 The Student Forum Act

Updated the Code of Laws to require an open student forum at every meeting.

### Bill 23-15 Committee Re-Apportionment Act

Required each committee to have at least 5 members and chair.

### Bill 23-18 The Cap Your Campaign Act

Provided \$250 for the Cap Your Can Campaign to promote alcohol education and safety.

### Bill 23-19 The College Outreach Tables Act

Provided funding for a Campus-Wide outreach tables in January.

#### Bill 24-01 Coupe D'e Code Act

Revised the method of Senator and Executive Officer evaluations.

#### Bill 24-02 Valentine's Day Party Act

Allocated Funding for an SGA social gathering.

#### Bill 24-03 Light The Fountain Contributions Act

Provided funding for two Bookstore Scholarships at Light the Fountain.

#### Bill 24-04 Senate Reports Act

Replaced Senator evaluations with Senate reports.

#### Bill 24-05 Freshman Forum T-Shirts Act

Provided funding for Freshman Forum's T-shirts.

#### Bill 24-06 Freshman Forum Advisors Requirements Act

Replaced the UPC Freshman Forum Advisor with a second Freshman Forum Advisor from Senate and revised qualifications for both positions.

#### Bill 24-07 Freshman Forum Advisor Salary Change Act

Revised the pay for the two Freshman Forum Advisors.

#### Bill 24-08 Freshman Forum Selection Committee Act

Replaced the Director of Student Engagement with the SGA President in the Freshman Forum selection process.

#### Bill 24-09 SGA Freshman Forum Advisors Act

Made the Code of Laws consistent with changes in regard to the removal of the UPC Freshman Forum advisor.

#### Bill 24-10 Freshman Forum Advisors Pluralizing Act

Made the Code of Laws consistent with changes in regard to the additional Freshman Forum Advisor.

#### Bill 24-11 President and Vice-President Term Requirement Act

Revised President and Vice-President qualifications to require that a person running must have served at least one semester in the Executive or Legislative Branch by the time election applications open.

#### Bill 24-12 Secretary and Treasurer Term Requirement Act

Made the Secretary and Treasurer qualifications equal to the President and Vice President in regard to time served in SGA.

#### Bill 24-13 The Mandated Officers Debate Act

Required that all candidates for President, Vice-President, Treasurer, and Secretary in order to run in the SGA elections, unless otherwise cleared by the Elections and Recruitment Committee chair.
