## Undergraduate Advisement Guidelines; P-3, K-6, P-12, and 6-12

### 1) UNA Email

- Check UNA email several times per week to avoid missing important information.

### 2) Advisor(s)

- Education advisor will be assigned upon completion of 45 credit hours. This is the primary advisor.
- Education majors (6-12, P-12 ONLY) should visit the department of teaching field for assignment of a content advisor.
- Meet with primary advisor during advisement each semester for issuance of registration PIN(s).

### 3) Fingerprint Clearance (ASBI/FBI fingerprints) & Liability Insurance

- Fingerprint clearance must be obtained before taking education classes. Visit the following website for more information: <https://www.una.edu/education/educator-preparation/fingerprint-clearance.html>
- Once completed, submit the confirmation letter (received via USPS) to the Educator Preparation office via email to [edprep@una.edu](mailto:edprep@una.edu).

### 4) ED 292 & Admission to the Teacher Education Program (TEP)

- Take ED 292 the semester applying to TEP. (example - If applying Fall 2024, take ED 292 the same semester, Fall 2024)
- Admission requirements for TEP include successful completion of an interview and meeting specified GPA requirements. Check the following link for specific due dates: <https://una.edu/education/educator-preparation/applying-to-tepgtep.html>

### 5) GPA Requirements for Undergraduate Admittance to TEP

- Undergraduate GPA requirements for the Teacher Education Program are:  
2.75 Institutional, 2.50 Overall, 3.0 Professional Studies and 2.50 Teaching Field

### 6) 4-year Plan

- All courses must be completed prior to internship. Plan accordingly, paying special attention to prerequisites.
- Keep track of when classes are offered so graduation is not delayed.
- It is the student's responsibility to read the catalog, create the 4-year plan, and register for the appropriate classes.
- Updated 4-year plans should be brought to all advisement sessions.

### 7) Financial Aid

- Student Financial Services, located in the Commons, is available to assist with financial aid for those who qualify.

- Apply for internship the semester before graduation. (example: If interning Spring 2025, apply for internship in Fall 2024)
